TIMBER MEASUREMENTS SOCIETY, APRIL 7-9, 2010, MONARCH HOTEL AND CONFERENCE CENTER, PORTLAND, OREGON MINUTES OF THE BUSINESS MEETING

Matt Fonseca called the Timber Measurements Society (TMS) business meeting to order on April 8th 2010. He started with the date for next year's meeting. In the past the Central meeting has always been held in the fall (with the exception of this meeting, which was postponed for six months as a result of the economic crisis). The group consensus was to hold next year's meeting in the spring (April 6-8, 2011). Jerry Ashby volunteered to work with the Northwest Log Rules Advisory Group to explore the possibility of a joint meeting, and in lieu of that to keep them posted as to the meeting dates of the TMS. He will follow up and report back at a later date on the subject of holding joint, back-to-back meetings.

Next were discussions and a vote on whether to continue the current three-day meeting format versus the past practice of two days of meetings. The pros and cons were discussed, a vote was taken, and the membership preferred a three day meeting.

Nominations for next year's meeting location were taken and voted upon. The meeting will be held in the Seattle/Tacoma area. Simpson Timber will provide a log rollout for the scaling field trip.

Next on the agenda was election of officers. Matt opened the floor for nominations for the chairman position. After much discussion Matt was nominated and reelected as chairman. The Chairman (Matt) noted that while he was willing and honored for the vote of confidence, the Society would be best served by some new ideas and vision.

Nominations for Vice Chairman were next and the Chairman suggested, and was granted by consensus, that we elect two Vice Chairmen in order to help in organizing the meeting. John Calkins and Mario Angel were nominated and voted to be the Co-Vice-Chairmen and will be assisting Matt with the meeting planning and organizing. As the meeting will be held in the Puget Sound area, Jerry Ashby kindly offered to assist as well.

Next was the position of Secretary/Treasury. The membership was pleased with the work of Thelma Alsup and nominated her for another term providing she was in agreement. Thelma said she would do it for another two-year term.

A letter will go out to the speakers, Interfor and Yamhill Log Scaling Bureau for their hard work on behalf of the TMS.
